Of the monetary benefits: it establishes the concession of these benefits, which according to his/her nature can be temporary or eventual. It also regulates that, in exceptional cases, the Ministry of Labor and Social Security may grant exceptional temporary monetary benefits from the Social Assistance System in amounts exceeding those contained in the established scale.

Temporary monetary benefits are those granted when the person or family members, for exceptional and justified reasons, present an emergent situation, are considered to be emergent, when they lack family support and income to assume the immediate basic expenses for the support of children, elderly people, disabled people, seriously ill people or other payments that cannot be postponed.

Temporary monetary benefits are those granted for a period of up to one year, when the situation of the core family that originated their concession is expected to be prolonged in time.

The amount of the temporary monetary benefits is fixed taking into account the established scale, conditioned by the number of members of the core family and the need for protection, for which it must be verified:

Inability of the members of the family core to take up employment, due to health conditions, disability or other causes that justify it.

Insufficient income to assume basic expenses.

Lack of obligated family members in a position to provide assistance.

Something you should know:

A family core is understood to be one or more persons who reside under the same shelter. In addition to the family relationship, affinity or cohabitation, there is a common participation in the economy of the core family.

The need for protection is determined when it is demonstrated that the members of the family core is unable to enter the workforce, due to health conditions, disability or other causes that justify it, there is a lack of income to pay for food, medicines, payment of basic services and the lack of family members obliged to provide assistance.

The need for protection of a family core may be raised by the interested parties themselves, social workers, political, mass and social organizations, institutions, district delegates, or any other person who so considers, to the Municipal Labor Directorate for its attention and evaluation.

Procedure for the comprehensive evaluation of the socioeconomic situation of natural persons applying for subsidies for constructive actions in their housing:

In order to comply with the regulations approved by Agreement No. 7387 of the Executive Committee of the Council of Ministers, for the granting of subsidies to individuals to carry out construction work in their homes, the Ministry of Labor and Social Security issues Resolution No. 47 of December 28, 201, which establishes the following procedure:

a) The work directions will carry out the socioeconomic investigations, at the conclusion of which a reasoned opinion is prepared and returned to the Municipal Housing Directions.
